# WHY CULT\_RISK

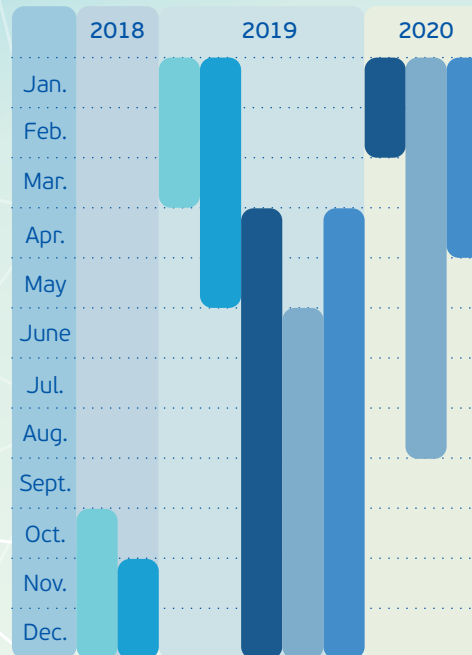
